## **Atlanta Chapter Enters the 21st Century!**

The Georgia Society is pleased to announce that effective September 1<sup>st</sup>, Atlanta Chapter members may now pay their 2021 dues online on the GASSAR website. This has been launched as a pilot program with seven chapters, Atlanta being one of the seven. Paying your dues has now become a simple process involving only a few clicks of your mouse.

#### • Registration will be required first:

- Accounts are managed within the website by email address. Therefore, only one account per email address may be established. There are accommodations for paying for family members or others using the same email address available in the website's menu.
- Registration can be done at <u>www.gasocietysar.org/login</u> or by using the "Members" menu entry on the home page.
- Enter contact information, NSSAR and GASSAR numbers, chapter affiliation and member type.
   Note: If the member is currently a Junior member and will turn 18 prior to January 1, 2021, the member should register as a regular member.
- Access to your contact information can only be made through your account. You will not be able to see anyone else's information.
- Member will also create a username and password. IMPORTANT!!! The security of your
  personal information is only as secure as the password you create. Please select a secure
  password.
- Once submitted, the submission will be reviewed for accuracy (correct numbers and member type). Any errors noted will be corrected if possible prior to account activation. If error cannot be reconciled, the member will be contacted which will delay account activation.
- Once approved, member will receive an email indicating account approval.
- o Login and pay your dues! Dues are to be received no later than December 1, 2020 this year.

#### Payments

- The payment system is handled outside of the GASSAR website by PayPal, a very secure and trusted worldwide platform to handle financial transactions.
- On the login screen you have two options for payment:
  - Login to your PayPal account and pay with PayPal
  - Use your credit/debit card as a guest without a PayPal account

# Georgia Society SAR Veterans Committee Message to all of our Chapter Members

#### Dear Atlanta Chapter Compatriots:

With the help of Compatriot Ron Hill and Commissioner Mike Roby, the GASSAR is starting to work more closely with the Georgia Department of Veterans Service (GDVS) and other veterans service organizations (VSOs) in anticipation of taking on larger scale veterans projects.

For example, the GASSAR proposes to help fund and participate in the TOGETHER AGAIN program being planned by the Military Officers Association of America (MOAA). They are planning a large gathering and celebration when the Georgia War Veterans Home in Milledgeville reopens its doors and allows loved ones to reunite with veterans living there. MOAA is negotiating special reduced hotel room rates for visiting families, and will help needy families with hotel and transportation costs.

The GASSAR's participation in the Wreaths Across America Christmas Wreath Laying Campaign, at the Marietta National Cemetery, will continue to be spearheaded by Compatriot Bill Kabel. Last Christmas, a wreath was laid at all of the 17,000+ graves at the cemetery. Clearly, we and our Partners in Patriotism are capable of handling projects much larger than our traditional donations activities; though there's no question that our generosity will continue in that area, as well.

A complete and accurate GASSAR Veterans Roster will be a vital asset for communications and management of such projects. So, I'm asking veterans -- and those who support veterans programs -- to complete and return a copy of the 2020 GASSAR Veterans Census Form. 


# DNA NEWS & the NSDAR

#### DAR Begins Accepting Autosomal DNA

Exciting news! DAR has begun to accept autosomal DNA (atDNA) and mitochondrial DNA (mtDNA) in addition to Y-DNA as evidence of lineage submitted with DAR membership Applications within the first three generations! DAR staff genealogists will now consider Y-DNA, autosomal DNA and mtDNA evidence along with more traditional genealogical sources during the verification of member-related Applications. This change will primarily benefit adoptees and children of adoptees. The National Society has accepted traditional paternity (and maternity) tests for more than 20 years.

With this change in policy, DAR recognizes the importance of autosomal DNA in genealogical research, but also that commercial autosomal DNA tests alone, like Y-DNA evidence, are not definitive enough to prove exact relationships. DAR staff genealogists will only consider Y-DNA 37 Marker and autosomal test results when traditional documentation does not exist or cannot be obtained due to sealed records. MtDNA will only be used in conjunction with Y-DNA or autosomal DNA.

Y-DNA and autosomal DNA as evidence to support DAR Applications

DAR began accepting Y-DNA evidence on January 1, 2014, in support of new member Applications and Supplemental Applications. DNA evidence submitted along with other documentation will be considered along with all other source documentation provided to prove lineage. Like the Y-DNA requirements, autosomal DNA



cannot be considered as stand-alone proof of lineage. In some cases, applicants may be able to use mtDNA in conjunction with atDNA to clarify relationships particularly when half siblings are involved.

Those applicants wishing to submit Y-DNA or autosomal evidence as proof of lineage along with other traditional proof documentation must submit Y-DNA or autosomal test results from at least two test subjects following the Y-DNA criteria outlined in the guidelines and test requirements found on both the public and member websites. Test results for all parties should be uploaded in the NSDAR DNA Group Project at familytreedna.org.

More information on identifying the specific types of situations in which DNA can be accepted by the DAR, as well as the testing and reporting methods for the surrogate Y-DNA and autosomal DNA test subjects, is outlined at <a href="https://www.dar.org/national-society/genealogy/dna-and-dar-applications">https://www.dar.org/national-society/genealogy/dna-and-dar-applications</a>.

Testing for DAR members has been established for those wishing to use the results for DAR Application purposes.

Family Tree DNA, the DAR's preferred testing partner, offers a special discount for DAR members when they join the

NSDAR DNA Group Project prior to ordering kits. Family Tree DNA is not the only provider of genetic genealogy tests, but it has the largest Y marker database in the world. The Y-DNA 37 test offered by Family Tree DNA includes a designated marker set that meets the reporting criteria outlined in the guidelines and test requirements for Using DNA Evidence for DAR Applications. #### DNA and DAR online genealogy course

Many advances have been made in the testing and interpretation of DNA results for use as evidence in genealogical research, but the information is still very complex. With the new DAR policy, DNA test results can be used for evidence of lineage for DAR Applications or Supplemental Applications, but specific criteria must be met. To help navigate how individuals can use DNA evidence for a DAR application, the DAR is revising its existing

online genealogy class "DNA and DAR." This special DNA online course is like the other DAR Genealogical Education Program (GEP) online courses, but it does not require any prerequisite classes prior to participation.

The "DNA and DAR" online course will introduce the basics of DNA and applying DNA to genealogical research, along with the impact of DNA on the process of documenting a DAR application. The course will cover other topics, such as guidelines for using DNA for DAR Applications; case studies for determining whether DNA evidence is an appropriate avenue of research for a particular Application and the steps you would take to take the test and how to interpret the results; along with specific instructions for submitting the Application with either the Y-DNA or autosomal report. The "DNA and DAR" updated online course will be available on August 1 for anyone to participate and costs \$100. The DAR genealogy staff's DNA study group will continue to use all types of DNA evidence in its own research, as well as monitor developments in the science of genetic testing. As with any new endeavor, the initial procedures and expectations may change at a future time. These changes may be in response to new science, new interpretations of existing data or the workload of the genealogy staff.

## **Guidance from NSSAR Genealogy Staff on DNA**

New perspectives on the legal issues that surround the use and dissemination of DNA test results have resulted in numerous questions regarding our current and future DNA policies, and our acceptance of test results, which may involve multiple individuals.

There are concerns raised by staff and our executives regarding how we will deal with the issues of privacy and confidentiality.

The current policy on DNA allows use of DNA states: DNA evidence can only be used as one element of a genealogical proof argument that includes additional conventional proof of the lineage. None of the major tests -- Y-DNA, autosomal DNA, mitochondrial DNA, or X-DNA alone can prove a descent from a specific individual. DNA tests can show with high probability that two individuals are related but without traditional evidence, they fail to determine whether the person being considered is a specific individual, a sibling of that individual, a cousin of, or other relation to that individual. However, by combining the various tests and using techniques to support predicted relationships, coupled with traditional evidence, a case can be built to demonstrate relationships.

The legal issue arises with the requirement for the additional conventional evidence. The conventional evidence required includes proof of the applicant's lineage to the common ancestor where a DNA match is found, the proof of the lineage of all matches to that same common ancestor, and proof of the lineage from the common ancestor to the patriot ancestor. This involves documentation for the lineages claimed by all of the matches used, which includes their private information. Their permission for use is needed and we need to address how to insure the privacy of that information used. A genealogy subcommittee is being set up to prepare guidance on how to build a DNA Proof Argument and to look into the questions regarding the use of DNA and who has permission to access and share this information.

When we accept results of a DNA test as part of a proof argument, we are receiving the most private of information. While we may have the permission of the applicant to use his DNA results, we do not necessarily have the permission of the other family members who are included in those results. They may not be aware that the SAR is being provided a copy of their DNA results as documentation.

We need to establish procedures that protect those DNA results from becoming available to the public through Record Copy and Documentation Requests.

With these types of questions in mind, the President General has asked the Staff to put a hold on any further acceptance of DNA test results as proof of lineage documentation.

This will be in effect until such time as the Chancellor General and the Legal Advisory Committee have an opportunity to review the National Society's standing from a legal prospective.

The Genealogy Subcommittee will continue to work on guidance for the types of reporting that would be required for DNA review, but any acceptance policy would need to be reviewed and include safeguards for its legal aspects. In the meantime, the Genealogy Staff has been instructed to automatically pend any application that uses DNA test results as proof or as part of a proof argument, pending the legal review by the Chancellor General and the Legal Advisory Committee.

In the interim, those applications already submitted but not yet reviewed will be pended and shelved until the Policy decisions are completed. Since this change in policy retroactively affects applications already in the queue, the National Society is offering a refund of the National application fees for those applications already submitted but not yet reviewed if a withdrawal of the application is requested.

## VA Canteen Coupon Books Project

At the beginning of 2019, our Chapter decided to take on a new veterans respect project. It decided to raise money to purchase VA Canteen Coupon books to be given to the Voluntary Service Office at the VA Medical Center, Decatur, for distribution to needy veterans. The coupons can be used in the VAMC's cafeteria, coffee shop, or canteen. Over the course of the year, a total of \$1,030 was raised which purchased 206 coupon books, each with a value of \$5. The last of the books were delivered on December 12, 2019. An example of their use was related by Wayne Bartley, Voluntary Service Specialist, who told Compatriot John Titus that on the day following our October delivery of 40 books, a homeless woman veteran with two children sought help. Our donated coupon books were used to provide the family with a meal before linking them with other services.

Thanks to all of our members for your continued generosity.

## **Veterans Respect Activities**

Our chapter began a new project in early 2019 to purchase VA Canteen Coupon Books which patients can use in the canteen, coffee shop or cafeteria at the VAH, Decatur. These books will be distributed by the VA Volunteer Service at the hospital. At each meeting there will be a jar marked "\$ for VA Canteen Coupon Books" to accept donations. Please look for it and contribute a dollar (or more).

The role of the Veterans Respect Committee is to pursue opportunities to honor and recognize current service members and veterans of past service. A wide range of activities fall under this charge. Some examples are:

- -hours served in the VA Hospital (VAH) Volunteer Service,
- -visiting a veteran in a VAH, nursing home or private home,
- -donating personal care items to a VAH or nursing home serving veterans,
- -donating publications to a VAH,
- -organizing an outing for one or more veterans,
- -participating in a veteran's funeral as a participant, pallbearer, or attendee,
- -attendance at Revolutionary War Veteran's Grave Marking,
- -participating in placing flags or wreaths on veteran's graves.

Dear Compatriots,

Veterans Committee members continue to receive inquiries about the new VA COVID-19 Needs List and Donation Form. The Atlanta VA Voluntary Service provided some guidance that would apply for VA Voluntary Service offices at all three of Georgia's VA Medical Centers.

With the exception Personal Protective Equipment (PPE) not new in the box, donation of any items on the VA needs list would be welcomed. Home made PPE simply cannot be used in a clinical setting. Gift cards for groceries, transportation, office supplies, personal care items and lodging would be used almost immediately, and many Compatriots have rewards points that could be converted into gift cards.

The new donation form and needs list are a step in the right direction in an era of social distancing. Most items on their needs list can be mailed to the VA Medical Center Voluntary Service office nearest the donor, saving long drives and complicated screening and check in procedures. Moreover, it assures that veterans in the donor's region are the people who benefit from the donation. Voluntary Service addresses are:

Please include a completed copy of the Donation Form with your gift to a VA Voluntary Service, so the gift can be reported to the VA National Headquarters. Also, be sure to retain a copy for your Chapter's donations records and a copy for yourself. These, and other donations or services to veterans are creditable for USS Stark Memorial Award points and Americanism points, which are recorded in your Chapter President's quarterly report to the GASSAR BOM.
